
**Sub.: Scholarship Scheme for students seeking admission at IKGPTU Main Campus and its constituent Campuses for academic session 2024-25 onwards.**

IKGPTU offers scholarship under Scholarship Scheme for the candidates willing to take admission in different Programmes offered in University Main Campus and its constituent campuses from session 2024-25 onwards.

The key points of this scheme are as under:

1. At the time of admission, student is required to pay full fees, except in the case of Tuition Fee Waiver scheme and Post Matric Scholarship cases.
2. On completion of admission process, based on qualifying examination (10+2 for UG and UG for PG programmes), the following is applicable:
  - i) Top 10% students admitted under same batch for all disciplines/streams will be offered scholarship of 50% of Tuition Fee and
  - ii) Next 10% students admitted under same batch for all disciplines/streams will be offered scholarship of 25% of Tuition Fee.
3. After completion of an academic year, scholarship will be revised based on aggregate SGPA of previous two semesters. All students will have an opportunity to compete for these scholarships. However, minimum required SGPA will be 7.5 (cleared in all subjects) to qualify and compete for scholarship among the students of same batch for all disciplines/streams. Head of Department of concerned discipline/stream will recommend the eligible candidates.
4. A student can avail only one scholarship scheme at a time only.
5. Scholarship amount will be refunded to the student by the University. Scholarship can be withdrawn by the competent authority, in case the student is found involved in misconduct throughout the session.
6. Scholarship for M.Tech. students will be made applicable on the basis of GATE score in accordance with AICTE guidelines.
